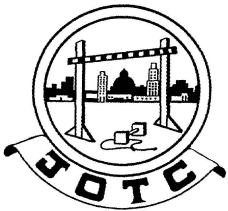

## MOVE-UPS FOR OBEDIENCE & RALLY

---

After a dog earns a title, it may be moved up to the next class in a future trial even though the closing date for the trial has passed. This move-up may be requested if, according to the owner's records, the dog has completed the requirements for the title after the closing date of the trial in which the advanced entry is to be made. The request for a move-up must be in writing and presented to the superintendent or trial secretary at least 30 minutes prior to the start of each trial. Move-ups may be approved, provided the next level class and judge are available and the class has not reached its limit.

## ATTENTION EXHIBITORS

---

- The Show Site will be available to exhibitors from 7:30 a.m. until 6:00 p.m. each day of trial. Dogs must be removed from the show site immediately after close of show on Sunday, July 03, 2011.
- Please bring waterproof covering to put under your crates.
- Breed and Group trophies will not be given out until 30 minutes after completion of the last class in which all eligible dogs are exhibited.
- All trophies must be claimed the day of the show - None will be mailed.
- Jackson Obedience Training Club, Inc. reserves the right to substitute a prize of equal or greater value.
- PLEASE NOTE: Refund of entry fees for bitches entered in Obedience that come in season after closing date of this show may be obtained by sending a veterinarian's certificate to the Trial Secretary. This certificate must be postmarked before the opening day of the show or given to the Trial Secretary before the start of the show. **A \$5.00 service fee will be deducted from refund.**
- **Obedience Fees Collected by AKC.** Effective for events held on and after January 1, 2009, the AKC will collect a \$3.00 AKC Event Service Fee for the first entry of a dog in all AKC licensed and member dog shows, obedience trials, and tracking tests. The current 50¢ recording fee will continue to be collected. A show-giving club shall assume the responsibility of collecting all recording fees and Event Service Fees for the American Kennel Club. (AKC "Rules Applying to Dog Shows", Ch. 11, Sect. 2)
- **Rally Fees Collected by AKC.** At every licensed or member club rally trial, a recording fee of \$3.00 shall be required for the entry of each dog. AKC "Rally Regulations", Ch. 1, Sect. 3
- CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS.
- There will be no refund for duplicate entries.
- Dogs need to be present only for scheduled judging and will be released if not needed for further judging.
- Dogs must be ready for judging. Neither the club nor its Trial Secretary will be responsible or obligated to furnish any service for notifying exhibitors or their agents of class judging. Judges need not wait for any dog holding up a class. **Owners or agents alone are responsible for the presence of their dogs in the judging rings.**

- **RETURNED CHECKS** do not constitute a valid entry fee. **The Trial Secretary will add a \$30.00 collection fee to the amount of each returned check.** Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis.
- Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or judge or barred from competition by action of the Show Committee.
- No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or the Trial Secretary.
- The show-giving Club, Trial Secretary, their agents, employees, etc., assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assume no responsibility for injury to children.
- **The Jackson Obedience Training Club, Inc. does not agree to arbitrate claims as set forth on the Official AKC entry form for these events.**
- No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. Entries will not be accepted without fees or signatures.
- Changes, additions or corrections to entry forms must be received in writing or by telegram prior to close of entries. Those received by telephone are not acceptable.
- **A \$5.00 administrative fee** will be charged for all cancellations made prior to closing of entries.

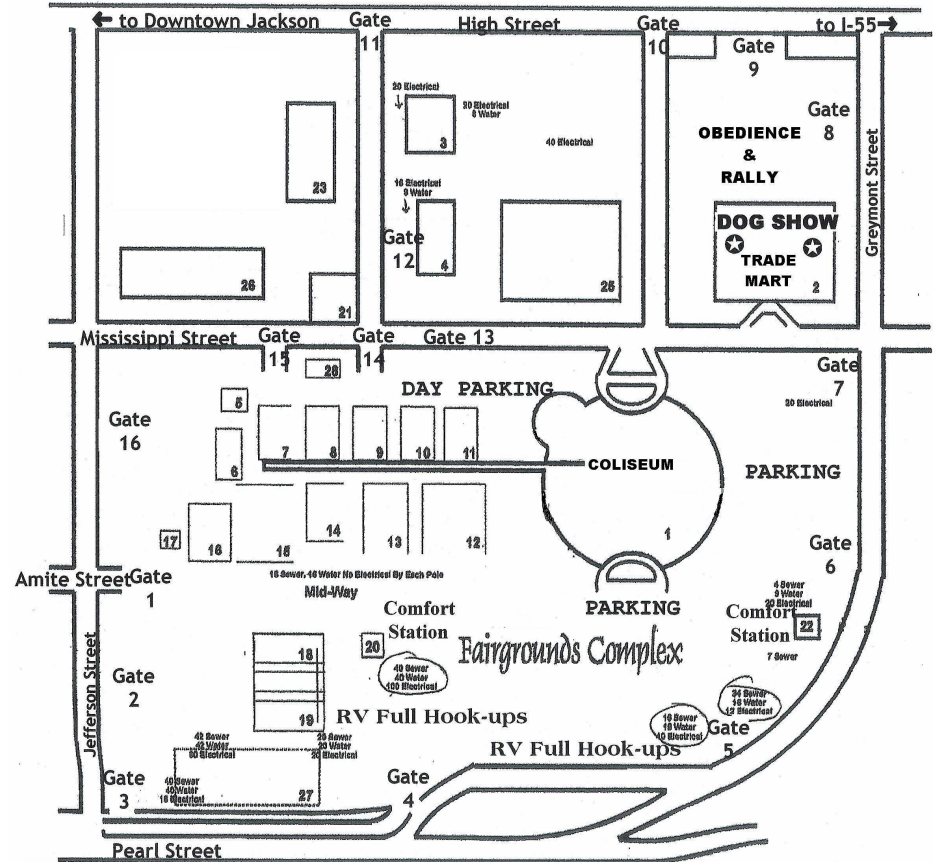

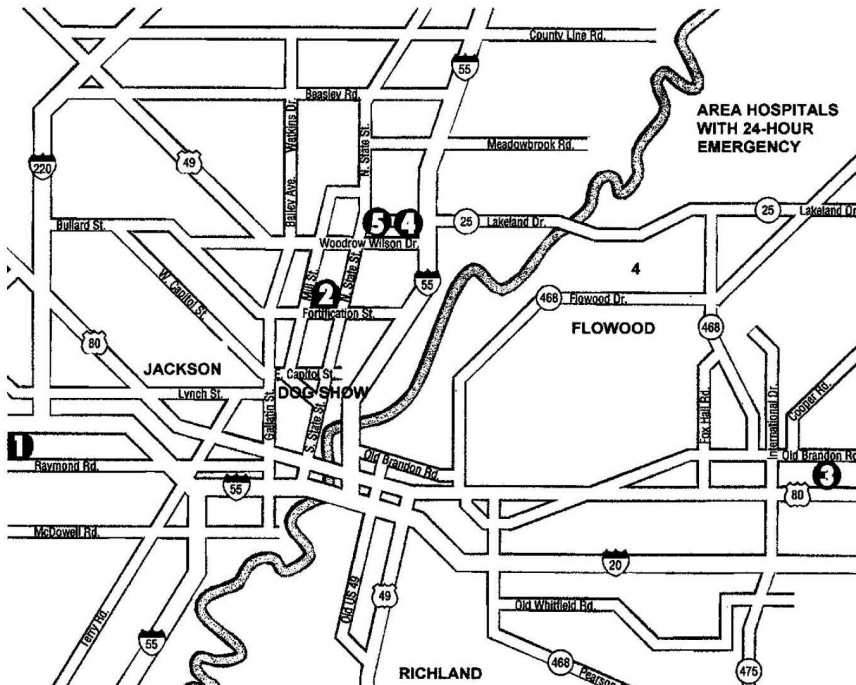
